Dutch Market Partner, located at Willemstraat 39, 5912 EN in Venlo, is responsible for the processing of personal data as set forth in this privacy statement.

1. Personal Data We Process

Dutch Market Partner processes your personal data because you use our services and/or because you provide this data to us yourself (for example, through our contact form or when requesting a market deep dive or report).

Below is an overview of the personal data we process (where applicable):

- First and last name
- Company name
- Email address
- Phone number
- IP address, location data, and data regarding your activities on our website (anonymized via Jetpack/statistics).

2. Special and/or Sensitive Personal Data

Our website and/or service does not intend to collect data about website visitors who are under 16 years of age, unless they have permission from parents or a guardian. However, we cannot verify whether a visitor is over 16. If you are convinced that we have collected personal data about a minor without such consent, please contact us and we will delete this information immediately.

3. Purpose and Basis for Processing Personal Data

Dutch Market Partner processes your personal data for the following purposes:

- To be able to call or email you if this is necessary to carry out our services.

- To offer you the possibility to create an account or to send you requested documentation (such as reports).
- Handling your payments and administrative obligations.
- Analyzing your behavior on the website in order to improve the website and to tailor the range of products and services to your preferences.

4. Automated Decision-Making

Dutch Market Partner does not make decisions based on automated processing on matters that can have (significant) consequences for individuals. This refers to decisions taken by computer programs or systems, without human intervention.

5. How Long We Store Personal Data

Dutch Market Partner does not store your personal data longer than strictly necessary to achieve the goals for which your data is collected. We apply a retention period for contact form and document requests for as long as necessary to fully handle your inquiry or the resulting business relationship. For fiscal data, we adhere to the statutory retention period of the Dutch Tax Authorities (7 years).

6. Sharing Personal Data with Third Parties

Dutch Market Partner does not sell your data to third parties and will only provide it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our behalf, we conclude a processing agreement to ensure the same level of security and confidentiality of your data.

7. Cookies, or Similar Techniques, That We Use

Dutch Market Partner uses functional, analytical, and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet, or smartphone upon your first visit to this website.

- We use cookies with purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered.
- In addition, we place cookies that track your surfing behavior so that we can offer customized content (such as analytical cookies from WordPress/Jetpack).
- You can opt out of cookies by setting your internet browser so that it no longer stores cookies.

8. View, Modify, or Delete Data

You have the right to view, correct, or delete your personal data. In addition, you have the right to withdraw your consent to data processing or object to the processing of your personal data by Dutch Market Partner, and you have the right to data portability.

You can send a request for inspection, correction, deletion, or data transfer to info@dutchmarketpartner.nl. To ensure that the request for inspection has been made by you, we ask you to send a copy of your proof of

identity with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number, and Citizen Service Number (BSN) to protect your privacy. We will respond as quickly as possible, but within four weeks, to your request.

9. How We Secure Personal Data

Dutch Market Partner takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure, and unauthorized modification.
